Upon completion and submission of the registration form and submission of the Method of Entry, and upon verification of the Method of Entry by Sponsor or Administrator, the entrant will receive one (1) entry into the Sweepstakes. A Method of Entry must meet all the applicable "Guidelines" set forth below to be considered valid.

- The Method of Entry must be the entrant's original work;
- The Method of Entry must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, including copyright infringement, or legal or moral rights of any third party, living or deceased (e.g., names, logos, symbols, slogans, photos or video that belong to others, photos or videos of other people, quotes from other people, or parodies of other people);

On or about January 3, 2025, the Administrator will also randomly select one (1) potential "Grand Prize" winner, as that term is defined in Rule 5, from among all eligible entries received during the entire Sweepstakes Period.  - C. Second Prizes (186 total, 3 per Second Prize Entry Period):** Each "Second Prize" is \$100 made payable to the Second Prize winner via Venmo. No more than one hundred eighty-six (186) Second Prizes will be awarded in the Sweepstakes – three (3) per Second Prize Entry Period. The ARV of each Second Prize is \$100.
 - D. Total ARV:** The total ARV of all available prizes in the Sweepstakes is \$39,600.
 - E. Odds of Winning:** The odds of winning a Second Prize depend on the total number of eligible entries received for the applicable Second Prize Entry Period. Sponsor, or its representative, will attempt to transfer each First Prize and Second Prize to applicable winner's Venmo/PayPal account associated with the email address used to register for the Sweepstakes within 8 to 12 weeks from verification of eligibility. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the prize, or any winner notification is returned as undeliverable or the potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, the prize may be forfeited. computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/Internet/Website/UseNet accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Website; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN NEW YORK COUNTY, NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
